

LEADERSHIP DENVER

HOW DOES A GROUP OF 55 PEOPLE ENACT COMMUNITY CHANGE?

Our flagship program, Leadership Denver, convenes a diverse group of leaders to learn about and discuss our region's issues. We challenge them to deepen their community engagement and create change around the issues for which they feel the most passion.



94% of LD '12 graduates feel more engaged in community and civic life after participating in the program.

62% of LD '12 graduates were most inspired to get involved in issues around education.





39% of Colorado fourth graders score proficient or better in reading. A child who can't read at grade level by the end of third grade is four times more likely to drop out of high school and not go to college. READ12 CLASS PROJECT

After learning about literacy issues in Colorado, LD '12 decided to make an impact through its class project. With support from Colorado Reads: The Early Childhood Literacy Initiative, LD '12 is launching the first "Read12" book fair at Hallett Fundamental Academy in May 2013. During the inaugural book fair, "Read12" will provide children in Kindergarten through second grade with 12 summer reading books. By providing high-quality reading materials to children from low-income homes, the project is helping to increase third grade reading proficiency and address the achievement gap. LD '12 plans to host additional book fairs in May 2014 and 2015.

LEADERSHIP EXCHANGE

WHAT CAN WE LEARN FROM VISITING OTHER CITIES?

A lot. That's why the Leadership Exchange program has been bringing Denver leaders to other cities for more than 20 years. In 2011, a delegation of 160 Denver business, government and nonprofit executives traveled to Boston to study the region's strengths and challenges.





93% of Leadership Exchange delegates feel more prepared to engage in Denver community issues after visiting Boston.

LEX BOSTON TAKEAWAYS

- Collaboration is key: Higher education, government and business must work together on shared priorities, such as education, infrastructure, health care and innovation to create a strong economic environment.
- Higher ed is big for business: Boston's educational institutions are incubators for innovation that produce an educated workforce and successful companies.
- P3s make a difference in P-20: Education reform can be achieved through public/private partnerships and by focusing on student needs.

INSPIRED ACTION

EX has the power to create tangible outcomes Here is what we've seen come to life this year:

Metro State University of Denver's newly opened Center for Advanced Visualization and Experiential Analysis (CAVEA) was inspired by Arizona State University's Decision Theater, which we visited during the 2007 LEX trip to Phoenix. CAVEA is a state-of-the-art theater space where leaders can make decisions through the use of computer modeling and simulation.

WHAT INSPIRES ACTION?

Knowledge about issues ignites the passion to get involved. Impact Denver is an introductory civic leadership program that provides the issues-based education needed to kick-start community involvement.



84% of Impact Denver '12 graduates feel more engaged in community and civic life after participating in the program.

33% of Coloradans volunteer in some capacity, which is higher than the national average of 26.5%. Our state's commitment to volunteerism has an economic value—an hour of volunteer work in Colorado is worth \$22.03. *Courtesy of Colorado in Context*



INSPIRED ACTION SIX PROJECTS - SIX MONTHS

ID '12 was challenged to take action on the program's first day when the class was divided into six project teams and tasked with helping a local nonprofit address an organizational or community need. One team worked with the Mental Health Center of Denver on a landscape project for the organization's Beeler Street Residence, delivering more than \$8,000 in improvements after securing in-kind donations from local landscapers and nurseries. Another team helped Reach Out and Read create a sustainable system to deliver more than 7,500 gently used children's books to health clinics throughout the metro area, making doctors' offices more literacy-rich environments.

That's why we brought 150 metro Denver executives to Fort Collins for Colorado Experience, a two-day experiential learning program that gave us an inside look at the northern Colorado region.

CSU Fort Collins is an economic engine: The campus conducts world class research and serves as an incubator for small business and big ideas, making an impact on both the local and global level.

LEGACY DENVER

WHAT ROLE DOES DIALOGUE PLAY IN SOLVING COMMUNITY ISSUES?

By discussing issues, we increase awareness and encourage problem-solving. Legacy Denver is a forum for Denver's business and community leaders to learn about issues of regional importance in a small group setting. This year's six groups were led by subject-matter experts who addressed topics including sustainability, public/private partnerships and working across sectors.

CREATING A MOVEMENT

During this year's CLA Summit, students were split into small groups and tasked with creating a movement around early childhood literacy. The teams presented their plans to a panel of judges that included executives from Teach for America and the Mile High United Way. Four winning teams were selected, and these students had the opportunity to meet with Lieutenant Governor Joseph Garcia at the Capitol in April 2012 to discuss their ideas. Lt. Governor Garcia engaged in lively dialogue with the students about the current challenges and potential solutions to Colorado's literacy issues.





Hispanic and African American students are three times less likely than white students to be proficient or better at reading. Hispanics under 18 are Colorado's fastest growing minority population. If we don't effectively narrow the achievement gap, our state's talent pool and economic security will weaken.

By hosting events like the annual CLA Summit, we help to educate, engage and inspire the next generation of leaders.

CELEBRATING CIVIC LEADERSHIP LUNCHEON

CAN ONE PERSON'S STORY GET PEOPLE THINKING DIFFERENTLY ABOUT THEMSELVES?

At this year's inaugural Celebrating Civic Leadership Luncheon, keynote speaker Liz Murray challenged the audience of more than 600 people to "create the extraordinary" in their lives. The child of drug-addicted parents who overcame homelessness and won a scholarship to Harvard, Murray's story of perseverance and hard work resonated deeply with those in attendance, encouraging them to think differently about overcoming obstacles—big and small—in their own lives.


